Product infromation

9. Product description

This EPD represents average grave stones made in Finland. The market of the product is Finland.

10. Technical specifications

Grave stones are manufactured from Finnish natural stone and they are used as memorials for deceased people. Grave stones typically have inscriptions, like the deceased person's name, which are engraved, glued or burned in to the surface of the stone. Grave stone includes both the headstone, where the name and other inscriptions are marked, and foundation stone, on which the headstone is placed upon.

11. Product standards

Stone properties can be received from the producers.

12. Physical properties

The size and dimensions of the stone vary. A typical grave stone is app. 60-80 cm high, 60-80 cm wide, and 15 cm thick. A typical aforementioned grave stone weighs (with its foundation stone) app. 300 kg.

16. System boundary


This EPD covers the following modules; A1 (Raw material supply), A2 (Transport), A3 (Manufacturing) and A4 (Transportation of the product to the building site) as well as C1 (Deconstruction), C2 (Transport at end-of-life), C3 (Waste processing) and C4 (Disposal). In addition, module D - benefits and loads beyond the system boundary - have been included. No modules or processes required by EN 15804 and RTS PCR were excluded from this assessment. No harmful substances were excluded from the study.

17. Cut-off criteria

Modules A1-A3 environmental impacts include all the used materials, energy, and transportation until the end-of-waste state. In addition, the vehicles and construction equipment used at the quarry have been considered. A4 transportation has been estimated to be 99 km, the return trip has not been considered. Of module C all impacts have been calculated (C1-C4). C1 includes the deconstruction. The distance for C2 has been estimated to be 50 km. C3 includes the energy use of rock crushing for recycling of the product (100 %). Module D considers the benefits of recycling and reuse of natural stone that replace primary material.

18. Production process

The products manufacturing stages: separation of the stone block, cutting it into smaller blocks and then into the wanted shape and size. After this the blocks are given a finishing treatment. A flow chart of the process is presented below

19. Environmental impacts

The results of a life cycle assessment are relative. They do not predict impact on category endpoints, exceeding of limit values, safety margins, or risks. The impacts are presented per declared unit, 1 ton of grave stone. The impacts are mainly caused by the manufacturing process (A3). The results are presented in scientific form, interpretation example: 3,54E-2 = 3,54*10-2 = 0,0354
